

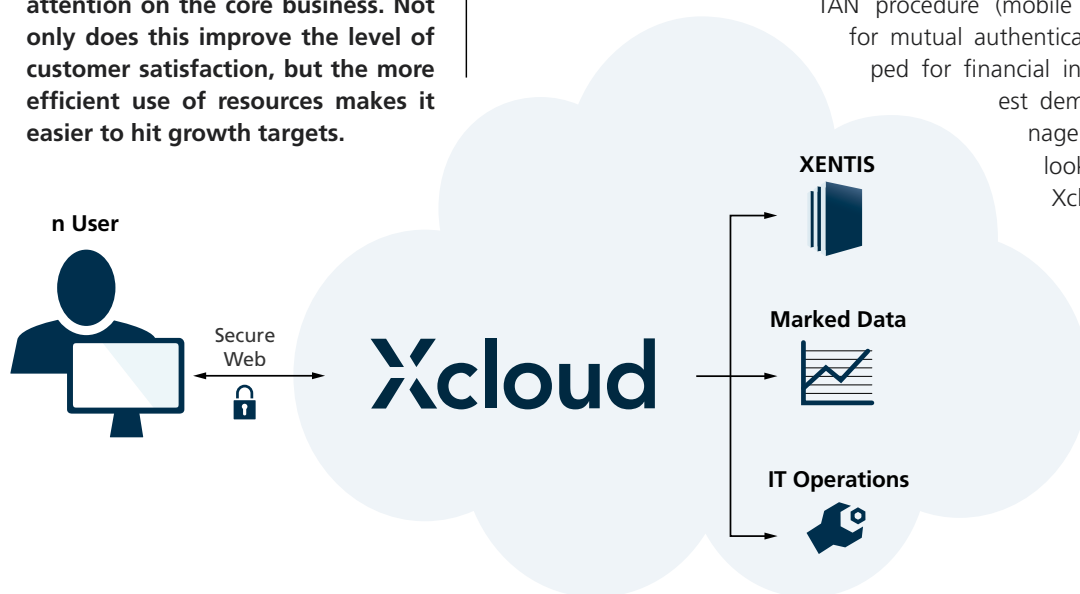
Xcloud – Best Practice for Individual Fund Administration
