# Coverage of the entire investment compliance process

XENTIS IC is a completely integrated one-stop solution: data and rule management, simulation and testing, pre-/post trade compliance check, monitoring-, workflow- and breach-management, reporting, audit, import/export of investment compliance rules.

#### Individuality as a standard

XENTIS IC combines the advantages of standardized software with the convenience of an individual solution. By separating the configurable system components from the standard product, changes to e.g. compliance rules, workflows, modelling investment types/asset classes and key figures can be carried out independently of release cycles. Customer-specific settings remains unaffected by software upgrades. An integration into existing system landscapes via standard interfaces is available in every XENTIS IC installation.

### High degree of flexibility and a powerful data structure system

One of the key strengths of XENTIS is the flexibility of its base design. This is particularly evident in the XENTIS IC module, which has to accommodate constantly changing legal and individual customer requirements. In addition, XENTIS IC offers a very flexible data structure allowing the customer to infinitely extend investment rules and maintain data fields (e.g. black/white lists, global or fund/mandate-specific, rating frameworks etc.) without any vendor support.

- Simple deployment of country rule sets / regulatory updates thanks to the automatic import/export feature
- Definition/setup of rules requires only minimal technical knowledge from users
- Intuitive, context-sensitive rule editor supports the end-user in defining rules
- Testing workflows with the built-in simulation center dedicated to testing/simulate master data and compliance rules
- Free configurable exposure calculation and hedging/netting methodologies



### Business rules and rule repository
